General Equine Activity Release & Riding Agreement

In riding the horse(s) owned by me or by boarder/owners at RideSport Stables, hereafter referred to as the Equine(s), the Rider and/or legal guardian accepts and agrees to all responsibility for their person(s).

The Rider/Participant must read, understand and agree to the following terms of this Riding Agreement. This Riding Agreement is for (date) _____ and will be retained on file in the event the Rider engages in this activity at this location in the future.

The Riding Agreement for the equine(s) negates all responsibility to the owner of the property Ridesport Stables, by the Rider or Participant for any injury or death associated with engaging in equine activities with the equine(s) on the property known as RideSport Stables, Hamel, Minnesota.

The Rider voluntarily and fully understands that equine activities are considered dangerous and can result in serious injury and even death to persons engaging in these activities. Horses are subject to flight or fight instincts when placed in a situation in which the equine(s) feels threatened. No amount of training can eliminate this instinct and thus the equine(s) is to be considered a possible danger to the Rider and to those persons engaging in all activities involving the equine(s). RideSport Stables owners/and or representatives cannot be held responsible for any and all injuries or death associated with engaging in activities with this equine(s).

The rider has been notified about the proper use of riding apparel, equipment for safety. This includes, but is not limited to, an approved riding helmet for children under the age of 18 either on or while handling any horse(s), hard footwear with a heel, and long pants. The Rider (if under 18) agrees to wear proper safety equipment as recommended by RideSport Stables owners/representatives.

The Rider and/or legal guardian is responsible for, and assumes the risk for any/all injuries associated with leading, riding, and tacking, grooming and general handling of all equine(s). The Rider will not place his person, those underage children or the equine(s) in any dangerous situation in which he, the children or the equine(s) can be injured or killed. This includes but is not limited to, riding in the indoor arena or outside arena, in and around the RideSport Stable property, riding at too fast a pace, jumping the equine(s) or placing more than one person at a time on the equine(s), or having equines in close proximity. The Ridesport Stables owners/and or representatives cannot be responsible for any and all injuries or death resulting from the Rider placing anyone or the equine(s) in a dangerous situation.

The rider is aware of and will follow all of Ridesport Stables barn/stable. These rules are for everyone on the property. The rider understands all of the stable rules and will abide by them at all times. Ridesport Stable owners/representatives cannot be responsible for any injury or death resulting from disobeying the rules. Failure to abide by these rules may result in immediate termination of riding privileges.

The Rider and owner have come to an agreement as set forth in this contract. Both parties understand their responsibilities during the term of this Riding Agreement. Any changes to the terms as set forth here are to be made in writing, signed and dated by both parties. The owner or Ridesport Stables Representative may terminate this activity release and riding privileges at any time.
